

From May 14 to 17, 2021, Invest in America and Data for Progress conducted a survey of 1,214 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

N=1214 unless otherwise specified. Some values may not add up to 100 due to rounding.

[1] The American Jobs Plan is a proposal to spend \$2.25 trillion over eight years to create millions of jobs by investing in infrastructure like roads, bridges, drinking water systems and electric grids and providing long-term care to seniors and people with disabilities. The American Families Plan is a proposal to invest \$1.8 trillion in families, workers, and job creation by providing paid family and medical leave to workers, funding universal pre-k, and making childcare more affordable, for example.

To pass it would require the use of a non-standard procedure called "reconciliation" that allows legislation to pass the Senate with a simple majority.

[3] Some lawmakers in Congress are proposing the \$2.3 trillion American Jobs Plan and a \$1.8 trillion American Families Plan to provide long-term care to seniors and people with disabilities, repair roads and bridges, remove lead pipes, create millions of good-paying jobs, guarantee all workers paid family and medical leave, make childcare more affordable, and invest in education.

This proposal would be paid for by making corporate taxes fairer, including closing corporate tax loopholes so that corporations can't deduct expenses incurred when they relocate jobs out of the U.S and raising taxes on higher earners.

As a counter proposal, some lawmakers in Congress are proposing a \$568 billion infrastructure bill that focuses only on repairing roads, bridges, other transportation and water systems, and expanded broadband access.

This plan would be paid for by using unspent pandemic relief money and through raising user fees from individuals, such as tolls, and increasing the gas tax.
