From April 23 to 25, 2021, Data for Progress conducted a survey of 1,189 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

[1] The American Rescue Plan, a \$1.9 trillion pandemic relief package signed into law in March 2021, expanded the child tax credit for most families.

Families receiving this tax credit will get a check of \$250 to \$300 each month beginning this July, rather than getting the money in a lump sum when they file their taxes next year.
