





From July 21 to 23, 2021, the Progressive Change Campaign Commitee, Student Defense, and Data for Progress conducted a survey of 1,186 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

N=1,186 unless otherwise specified. Some values may not add up to 100 due to rounding.

[1] As a result of the pandemic, the federal government
