From December 3 to 6, 2022, Data for Progress conducted a survey of 1,194 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[4] The Health Insurance Portability and Accountability Act of 1996 (HIPAA) is a federal law that prevents medical health records from being released without the patient's consent.

This privacy rule has exceptions allowing the release of medical information without a patient's consent in certain situations, such as cases of domestic violence and abuse or when law enforcement is involved. Following the Supreme Court decision to overturn the protected right to an abortion, states where abortion is illegal could also require health providers to release relevant records on reproductive care and abortions to law enforcement.
