From June 14 to 23, 2022, Data for Progress conducted a survey of 2,954 voters in Michigan, including an oversample of undecided voters, using SMS respondents. The sample was weighted by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ±2 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[1] When the Supreme Court legalized abortion in Roe v. Wade, the 1973 ruling that protected women's right to abortion, it put on hold a 1931 Michigan law that criminalized abortion, even in cases of rape or incest.

If Roe v. Wade is overturned, abortion could be criminalized again in Michigan in all cases except when a woman's life is endangered.
