

DATA FOR **PROGRESS**

From August 3 to 7, 2022, Data for Progress conducted a survey of 770 likely voters in Arizona using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ± 4 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[9] The Inflation Reduction Act of 2022 proposes a tax increase on "carried interest income."

Under current rules, this income is taxed at a much lower rate than ordinary income. This loophole allows some wealthy Americans to pay a lower tax rate on a significant bulk of their earnings.

Closing this loophole will help generate \$14 billion in revenue and ensure millionaires and billionaires pay their fair share.
