From October 20 to 21, 2023, Data for Progress conducted a survey of 1,222 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

Supporters say that each year tens of thousands of Alaskan salmon are unintentionally caught and discarded by trawlers, contributing to the recent collapse of salmon harvests across Alaska's rivers. This has devastated many Alaska Native communities who rely on subsistence fishing for their food supply. The people most directly impacted should be explicitly included in the Council; currently no voting members are Alaska Native.

Opponents say the Council should represent and support the seafood industry, not threaten hard-working fishermen with burdensome over-regulation. Many factors affect future salmon returns across Alaska, and the seafood industry discards a relatively small number of Alaskan salmon. Anyway, Alaska's governor can always appoint Native members to the Council and has in the past.

[3] Approximately one in five Alaskans live in rural areas, most of whom are Alaska Native. In these rural villages, fishing is critical not only for food — subsistence fishing constitutes about 60% of what rural Alaskans eat — but also essential to the cultural and spiritual wellbeing and survival of Alaska Native people.

The last few years, salmon runs in western Alaska have collapsed, a crisis that threatens both food security and cultural heritage for many rural villages.

Government officials all agree that in rivers where salmon are scarce, fishing should be limited to subsistence use. But there is disagreement about whether subsistence fishing should be limited to rural residents, or open to all residents.

When salmon are scarce in a river, some officials have pushed to limit fishing to rural residents. Other officials have pushed to open fishing to all residents, not just rural residents, arguing that the Alaska state constitution requires opening subsistence fishing to all Alaskan residents.
