## D DATA FOR PROGRESS

From October 31 to November 2, 2023, Data for Progress conducted a survey of 582 likely 2023 voters in Ohio using SMS and web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is $\pm 4$ percentage points.

NB: subgroups with a n-size less than $50(<50)$ are not shown on these cross-tabs. We choose not to display $\mathrm{N}<50$ subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Partisanship reflected in tabulations is based on self-identified party affiliation, not partisan registration. Some values may not add up to 100 due to rounding.

[1] On November 7th, 2023 voters in Ohio will decide whether to enact State Issue 1, a proposed amendment to the Ohio Constitution. If passed, this amendment will go into effect 30 days after the election.

The proposed amendment would establish a state constitutional right for an individual to carry out their reproductive decision without state interference. It would also prohibit the state from restricting abortion access from patients who medically need the procedure to protect their lives.
