## **M** DATA FOR **PROGRESS**

Below are results from national polling conducted from September - November, 2023 and weighted to be representative of the likely voter population. These surveys were conducted by the Progressive Change Campaign Committee and Data for Progress.

From September 27 to 28, 2023, Data for Progress conducted a survey of 1,255 U.S. likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Partisanship reflected in tabulations is based on self-identified party affiliation, not partisan registration. Some values may not add up to 100 due to rounding.

From July 19 to 20, 2023, Data for Progress conducted a survey of 1,254 U.S. likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Partisanship reflected in tabulations is based on self-identified party affiliation, not partisan registration. Some values may not add up to 100 due to rounding.
