

☐ DATA FOR **PROGRESS**

From March 3 to 6, 2023, Data for Progress conducted a survey of 1,226 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[2] Congress recently passed a bill that would ban financial managers from considering environmental factors, such as climate risks or the riskiness of investing in fossil fuels, when deciding how to invest retirement funds.

This would mandate where retirement funds and pensions would be invested, essentially locking them into investing in risky big oil and gas companies and taking away the flexibility to invest in new clean energy projects like wind and solar power.
