M DATA FOR **PROGRESS**

From March 28 to April 4, 2023, Data for Progress conducted a survey of 450 likely voters in New York's 17th Congressional District using SMS and web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±5 percentage points.

Partisan switchers are defined as likely voters who have reported voting for both Democrats and Republicans in the past, such as Biden-Zeldin voters.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.
