



From April 21 to 23, 2023, Data for Progress and Climate Power conducted a survey of 1,259 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[5] The debt ceiling is the amount of money the U.S. government can legally borrow to pay its existing bills. The debt ceiling is set by Congress. The U.S. hit the debt ceiling earlier this year, and is on track to default on its debt this summer, which would mean the U.S. will be unable to meet its financial commitments unless the debt ceiling is raised.

Republicans in Congress are proposing cutting provisions of the Inflation Reduction Act, the clean energy plan that Democrats passed last year, in exchange for raising the debt ceiling.

Below are statements from a Democrat and a Republican.

Republican: We should end the climate giveaways put in place by the Inflation Reduction Act that waste taxpayers' money, drive up national spending, and damage the domestic economy by making America more dependent on China. We will recoup billions of dollars in wasteful climate spending by reversing the green energy tax credits in the Inflation Reduction Act.

Democrat: The passage of the Inflation Reduction Act (IRA) has already spurred hundreds of billions of dollars in private investment and includes projects that promise nearly 150,000 good-paying jobs across 41 states. These investments are already bringing supply chains and manufacturing back to the United States, and to repeal the IRA's clean energy investments would stifle our energy and manufacturing industries.
