[2] Recently, reporters learned that Supreme Court Justice Clarence Thomas has received extensive financial gifts from Harlan Crow, a billionaire who has made significant political donations exclusively to Republican candidates and causes.

According to reports, Crow has taken Thomas on luxury vacations nearly every year, including about a week every summer at Crow's private resort in the Adirondack Mountains, and chartering a private jet and yacht in Indonesia.

Thomas has never disclosed these vacations, even though they cost hundreds of thousands of dollars. According to legal experts, failing to disclose these vacations could be in violation of a law that requires justices and other federal officials to disclose most gifts.

Do you think Thomas' luxury vacations with Crow, and his decision to not disclose them, is ethical or unethical?

[3] Reporters have also discovered that Supreme Court Justice Clarence Thomas made a real estate deal with Harlan Crow, a billionaire who has made significant political donations exclusively to Republican candidates and causes.

In 2014, one of Crow's companies purchased a string of properties in Savannah, Georgia that were owned by Thomas and his family, for \$133,363. Thomas did not disclose this sale, even though federal disclosure law requires justices and other federal officials to disclose most real estate sales over \$1,000.
