[4] Currently, about 1 in 4 rifles in the U.S. are imported from foreign countries. Many of these rifles are allowed to be imported because they are for "sporting purposes."

[6] Recently, a new "tag" was created for firearm and ammunition retailers, similar to the standard "tags" that exist to categorize other types of retailers. This means that every time someone makes a purchase from a gun shop with their credit card, it is tagged as a firearm-related purchase.

Supporters say that this tag filled a gap in the existing list of codes and is important to help prevent mass shootings and save lives. Banks and credit card networks can use the data from these tags to detect suspicious patterns of firearm purchasing, such as patterns associated with straw purchasing, gun trafficking, or stockpiling of thousands of dollars' worth of firearms within a few days. They could then report the activity to investigators to prevent gun violence, similar to how they report other types of suspicious purchases.

Opponents say that these tags are unnecessary and are an attempt to restrict Americans' freedom to own firearms. They say that Americans should have the freedom to purchase firearms as they wish without their purchases being tracked and analyzed. They argue that these tags would violate the constitutional rights of American citizens, intrude on consumer privacy, and potentially cause issues for gun stores and consumers that are abiding by the law.
