

From February 23 to March 2, 2024, Data for Progress conducted a survey of 1,120 likely voters in Alaska using SMS and web panel respondents. The sample was weighted to be representative of likely voters by gender, education, race, geography, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[3] Some lawmakers are proposing to increase the amount of money public schools in Alaska receive per student each year from the state government, known as the Base Student Allocation (BSA).

Supporters say there should be a large increase in the BSA. Inflation has seen costs rise by 27% while state funding has stayed virtually unchanged, resulting in crippling staff shortages and program eliminations.

Opponents say there should be a small or no increase to the BSA. A big increase would be fiscally irresponsible and unfocused education spending does not mean better results. The state should focus on more targeted investments like teacher bonuses.

[7] Approximately one in five Alaskans live in rural areas, most of whom are Alaska Native. In these rural villages, fishing is critical not only for food — subsistence fishing constitutes about 60% of what rural Alaskans eat — but also essential to the cultural and spiritual wellbeing and survival of Alaska Native people.

The last few years, salmon runs in western Alaska have collapsed, a crisis that threatens both food security and cultural heritage for many rural villages.

Government officials agree that in rivers where salmon are scarce, fishing should be limited to subsistence use. But there is disagreement about whether subsistence fishing should be limited to rural residents, or open to all residents.

When salmon are scarce in a river, some officials have pushed to limit fishing to rural residents. Other officials have pushed to open fishing to all residents, not just rural residents, arguing that the Alaska state constitution requires opening subsistence fishing to all Alaskan residents.

Some policymakers are proposing that Alaska Native entities be included in a co-management and cooperation agreement with state and federal governments on some lands conveyed to Alaska Native corporations through the Alaska Native Claims Settlement Act (ANCSA).

[11] America's two largest grocery store companies are planning to merge.

Kroger, which owns Alaska's 12 Fred Meyer stores, owns more than 2,700 locations across the United States. Albertsons, the second-largest with almost 2,300 locations nationwide, owns Alaska's 35 Safeway and Carrs locations.

Supporters say that the two companies must merge to compete with mega-chains like Walmart and Costco that increasingly dominate the grocery business. Owners have the right to do what they must to make businesses competitive and they promise to use savings from increased efficiency to lower prices and raise wages.

Opponents say because Fred Meyer and Safeway/Carrs are each other's primary competitors in Alaska, store closures and reduced competition will result in a near-monopolistic landscape and higher prices. When Safeway and Carrs merged in 1999, stores were closed and workers lost their jobs, leaving communities without competition.

The standard would ensure 25% of power is generated from renewables by 2027 and aims for 80% renewables by 2040.
