# 

From July 21 to 27, 2025, Data for Progress conducted a survey of 678 likely voters in Alaska using SMS and web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and recalled vote. The survey was conducted in English. The margin of error associated with the sample size is ±4 percentage points. Results for subgroups of the sample are subject to increased margins of error. Partisanship reflected in tabulations is based on self-identified party affiliation, not partisan registration. For more information please visit dataforprogress.org/our-methodology.

NB: subgroups with a n-size less than 40 (<40) are not shown on these cross-tabs. We choose not to display N<40 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[11] The governor of Alaska recently vetoed a bill that would have let the legislature see more detailed information about how much oil companies pay in taxes. Every previous governor made this kind of information public, and the current governor has not.

Supporters say the governor is breaking the law and protecting oil companies by hiding these records. They point out that oil tax payments into the state's savings fund dropped from \$281 million in 2020 to just \$3 million in 2024, and argue he wouldn't be blocking transparency unless he had something to hide.

The governor says he vetoed the bill to protect private tax and business information. He says the state already makes sure oil companies pay what they owe, and that giving lawmakers more access could cause legal problems or political interference.

[17] Some lawmakers are proposing to require large online companies like Amazon and Netflix to pay state tax in Alaska. Right now, these companies operate in Alaska but don't pay tax here. The money raised from the new tax would go toward public education.

Supporters say this is a fair way to fund schools by making big nationwide companies pay their share, just like local businesses do. They note that most other states already have similar

Opponents say the tax could lead to higher prices for customers or make companies less willing to do business in Alaska. They argue that adding new taxes will slow economic growth and may eventually hurt local jobs or investment.
