From July 3 to 4, 2025, Data for Progress conducted a survey of 1,152 U.S. likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and recalled presidential vote. The survey was conducted in English. The margin of error associated with the sample size is ±3 percentage points. Results for subgroups of the sample are subject to increased margins of error. Partisanship reflected in tabulations is based on self-identified party affiliation, not partisan registration. For more information please visit dataforprogress.org/our-methodology.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. [1] The Occupational Safety and Health Administration (OSHA) proposed a rule to protect workers from extreme heat. The rule would require employers to:

- Provide accessible drinking water
- Provide designated shaded or indoor break areas
- Have a protocol for new employees to gradually adjust to working in heat
- Use air conditioning or have air circulation in indoor if temperatures reach 80 degrees Fahrenheit or higher
- Enforce mandatory rest breaks, buddy systems, or supervisor observations in heat above 90 degrees Fahrenheit
- Train employees on symptoms of heat illness and emergency protocols, in multiple languages
