

Appendix A: Corporations That Have Financially Contributed to Campaigns of Officials Behind Anti-LGBTQ+ Policies

This list cannot capture the money corporations direct to state lawmakers through super PACs, which they are not required to disclose. It also does not capture the contributions corporations make to state Republican organizations that may have provided support to the legislators behind anti-LGBTQ+ legislation – or even helped orchestrate such legislation – as the circuitous nature of that support can make tabulating it potentially less accurate or actionable. The totals listed here should be considered an absolute minimum of what major corporations have actually contributed to these politicians, and many corporations are not listed here because their contributions are not traceable through public records research. Reasonable efforts have been taken to ensure the accuracy of the data, and any corrections can be directed to info@dataforprogress.org.

Methodology

Data Selected

The legislation included in this analysis, detailed above, includes Florida's HB 1557; Arizona's SB 1138; Idaho's H 675; Alabama's SB 184, HB 266, and HB 322; Tennessee's HB 2670/SB 2290; and Texas' February 22, 2022, executive directive to the Texas Department of Family and Protective Services and OAG Opinion No. KP-0401.

Included in this data are all monetary contributions by corporations and corporate PACs – Pride event corporate sponsors, Fortune 500 companies, or both – to the candidate committees of all legislators listed as authors and/or official sponsors of these policies, and the governors that signed them. A full list of these legislators is available in Appendix B. Data are limited to contributions in the 2020 and 2022 election cycles, through December 2021 and not including contributions reported in any end-of-Quarter 1 filings, made public after the conclusion of our data collection process.

Not included in this data are non-monetary contributions, loans, or contributions made by executives or other employees of the corporations. Again, the totals above should be considered an absolute minimum of what these corporations have actually contributed.

Categorizing Corporations

For the purposes of this analysis, a corporation is considered “responsible” for contributions made by its subsidiaries and franchises, and, where applicable, corporations are listed in the table above by the parent corporation, regardless of whether the parent or a subsidiary corporation is listed on campaign finance filings as the contributor of record.

A corporation is flagged as a Pride sponsor if the corporation or any of its subsidiaries or affiliates is listed on the official Pride event websites as sponsors in San Francisco, New York City, Seattle, Los Angeles, Chicago, Houston, Atlanta, and/or Miami as of April 2022, which might include 2021 event sponsors, 2022 sponsors, or both.

A corporation is flagged as a [HRC Pledge](#) participant if it was listed as a signer as of April 2022; we understand additional corporations have signed onto the pledge in recent weeks, so the live list might include additional corporations than identified here that have contributed to anti-LGBTQ+ politicians.

Finally, we utilize the 2021 Fortune 500 rankings, the most recent available.
