# Candidate Climate Plan Summary

## **ELIZABETH WARREN**

### **ABOUT THE PROJECT**

The Green New Deal is an ambitious policy agenda to tackle the climate crisis, create quality jobs, and promote justice. It has become a core element of many Democrats' platforms in the 2020 Presidential race, with more than half of all candidates endorsing the Green New Deal and widespread, bipartisan support among American voters.

To determine the thoroughness of each candidate's climate platform in addressing the features of the Green New Deal and allow for some basis for comparison, Data For Progress created a Candidate Climate Plan Summary for the debate-eligible Democratic candidates' climate policy proposals to-date. We include on a rolling basis candidates with published presidential campaign plans, rather than public statements or legislative history. Using a rubric of 48 essential Green New Deal components, we identify where each candidate 1) addressed a component with a proposed federal policy or action, 2) acknowledged a component but lacked clear policy details, or 3) did not include a component. We assess only the presence of specific components, but do not evaluate the merits of any particular approach.

Warren's climate policy is a package of 11 plans that leverage federal investment in research & development, government procurement, climate risk disclosure, and global trade agreements to reach net-zero emissions by mid-century. Her 100% Clean Energy for America plan is modeled on Governor Inslee's plan by the same name, and sets ambitious short-term targets for decarbonizing buildings (2028), new vehicles (2030), and electricity (2035). Policy highlights include her Green Marshall Plan, which would provide environmental development assistance to other countries; a moratorium on fracking and fossil fuel drilling on public lands; a new Federal Renewable Energy Commission, as well as fast-tracking of offshore renewable energy projects; a border adjustment to avoid emissions leakage overseas; a blue carbon program for ocean carbon dioxide sequestration; and climate justice screens on all mitigation and adaptation efforts.

## COMMITMENT TO GREEN NEW DEAL PRINCIPLES

*The Green New Deal is an ambitious plan for climate action, job creation, and justice.*

Senator Warren's climate platform includes strong labor protections, antitrust safeguards against corporate overreach, and recognition of Indigenous sovereignty. It sets specific targets for decarbonization of the transportation, buildings, and electric sectors.

Warren's climate package is specific about which government agencies and procurement processes it will leverage, which may enable quick implementation. It also creates new research and development programs and authorities, such as a National Institutes of Clean Energy and Federal Renewable Energy Commissions. Her net-zero military proposal exercises the capability of Department of Defense for research and innovation.

When combined with other parts of her platform, including single-payer universal healthcare and affordable housing, Warren's inclusive climate policies align with a broader social safety net.

## USE OF EXECUTIVE AUTHORITY

Data For Progress looked at which components of the candidates' plans invoked the use of executive authority. Executive and legislative pathways each have their own advantages, so this is not meant as a value judgment on the strength of a climate plan.

Warren has expressed a willingness to declare climate change a national emergency. Additionally, we find **17** components of a Green New Deal for which Warren is likely to leverage executive authority, as determined by explicit statements in her plan or Data For Progress analysis. Notable executive actions include:

- ▶ Achieving a carbon-neutral power sector by 2030
- ▶ Strengthening methane, vehicle, and building standards
- ▶ Prosecution of polluters for current and historic damages
- ▶ Implementing environmental justice and equity screens across federal agencies
